Thank you to everyone who came to support the table top sale in aid of the Mother and Toddler group and, in particular, thank you to all those who came to support my stall on that morning. I enjoyed talking to you all and showing my range of goods and hope that those of you who made purchases are pleased with the results.

It has come to my attention that there are a lot of people locally who suffer to some extent with arthritis. In response here is some information which may help.

There are some foods which are known to be irritants to arthritis suffers, namely: sugar, hydrogenated fats found in margarine and many processed foods, instead try using olive oil or a little butter; potatoes (sweet potatoes are better), peppers and cooked carrots (raw is fine) are out, together with bananas and oranges, and in are all green vegetables, salad leaves, onions and garlic, avocado, kiwi, apples, pears, strawberries, raspberries, cranberries, blueberries, kiwi and dried plums. Especially good are wholegrain brown rice, lentils and cooked beans, and to be avoided are grains, especially wheat which occurs in most breads, biscuits, cakes etc. Oats are acceptable and some pasta, but do try the non-wheat varieties.

Chicken, turkey and lamb are preferred to pork and beef. The better protein option is oily fish which can include tinned salmon, tuna, sardines etc. and eggs, cheese, skimmed milk and yoghurt. Brazil nuts, almond and walnuts are excellent (avoid peanuts) and seeds are good too e.g. sunflower, sesame, almond and walnut. Tea and coffee are on the bad list so at least cut down, water and herbal teas are fine - alcohol in small quantities only! My advice is do not try it all at once, but cut out one food group at a time and gradually change to a more suitable diet for your condition. The fish oils are most important and you can supplement those too. Aloe Vera is extremely good for arthritis and Forever Living Products sell one called Forever Freedom consisting of Aloe Vera which contains natural anti-inflammatory properties, Glucosamine which helps to protect cartilage and can even encourage cartilage growth, Condroitin which helps to prevent the breakdown of cartilage and MSM sulphur which promotes healthy cell growth and helps to eliminate toxins. The usual cost for one litre is £24.58 which is good value as it combines 4 components which are expensive in themselves. However I am making a special offer of just £20 until the end of June if you would like to try this. It does come with a 60 day money back guarantee if you really cannot stand it!

Pastoral Letter from the Vicar of Fordham

Some people say that May is Mary's month (Mary, the mother of our Lord, that is), though I've never been absolutely clear why, since only one of her feast days, the one which commemorates her visit to Elizabeth, occurs in May. This year we might say, with at least as much justification, that June is Peter's month. Near the beginning of the month we celebrate the Feast of Pentecost, the day the Holy Spirit swept all the apostles out of their hiding place and into the street and Peter conquered his fear and became their spokesman: preaching the gospel to a great crowd and converting 3,000. He never looked back. He became the leader of the Church in Jerusalem and later travelled to Rome, where he was martyred, and became revered as the first bishop of that great city and thus, by tradition, the first pope.

At the end of June, on the 29th, we celebrate Peter's own day. St. Peter's Day is, of course, Snailwell's patronal festival. Petertide has also long been the traditional time for the ordination of deacons and priests and this year we have a special interest in the ordination which will take place in the cathedral on the 28th. At that service Michael Banyard, who is to be assistant curate in the Three Rivers Group, living in the vicarage at Chippenham, will be ordained deacon and begin his ministry among us.

Mike had a long career in teaching, both in this country (at Ely College) and abroad in forces schools in Cyprus, Germany and Hong Kong. But ordination to the priesthood was something he had long felt a call to, and when the handing back of Hong Kong to China resulted in his taking early retirement he took the opportunity to test his vocation. Having been recommended for training, he took up a place at Westcott House in Cambridge and now finds himself on the brink of fulfilling that long-held dream.

Interestingly, I recently attended a day course exploring some of the changes that are due to take place in Anglican liturgy - not, I hasten to add, in the normal Sunday services we have so recently revised, but in those which have not yet seen that revision process completed, notably, the ordination services. The revisions are a long way from being completed, but one of the things which is proposed for the new services is that they will begin at the font, for this is where all our ministry begins. St. Paul famously spoke of the Church as the 'priesthood of all believers'. In our baptism services the newly baptised are given a lighted candle, taken from the light of Christ as symbolised in the Easter candle, and we, or our parents and godparents, are reminded that Christ calls us to be his lights in the world. And to be that, is to be a minister of Christ. That moment is just the beginning of our pilgrimage of faith. If we are prepared to allow God to lead us on that pilgrimage, he will show each of us what he has in mind for us. It might be ordained ministry or some other licensed lay ministry. In the other hand, it might be something we wouldn't immediately recognise as ministry, and yet, guided by him, we will still be doing

Wildtracks planning applications

Letter to the Editor A personal point of view

"After reading about the set back in planning permission for a hotel at Wildtracks on the A11, I thought that it was time that a point of view from someone that could be affected by the decision should be heard.

I first started working at Wildtracks in 2000. This came about because I felt that having to pay to live in Sheffield for only 13 hours of lectures in a week at the University was a waste of valuable time and money. I started working at weekends doing menial tasks such as cleaning toilets, clearing litter and marshalling at moto-cross events. This employment, especially involving weekends, gave me the opportunity to start a degree course again. I am now about to enter the final stage and hopefully get my BSc. Thanks to Wildtracks I earned enough never to need a student loan to pay my educational fees. I have bought my own car and a guitar that I only dreamt about. What is my point in this insight into my personal circumstances? It is simply to let you people out there know that when you start opposing any sort of change in your local environment you often overlook the needs of other people in your society, especially the young. Many young people never have the opportunity that Wildtracks has given me. They need opportunities and experience to start them off in life. Wildtracks currently employ around 10 young people at £25 per day at the weekends. Also they are welcome to use the facilities free of charge. And they are gaining experience for later in life.

I would like to question another part of the objection to planning. How can the Parish and District Councils raise objections over increased traffic? I am constantly meeting visitors to Wildtracks, I know that well over 95% of them come via the major roads, the A11/A14, not through local villages as has been stated.

If the local councils were so serious about traffic flows why do they do nothing to ease the situation that is the real cause for concern? Take Chippenham. The local councils turned down the offer of free land to enable the building of a roundabout at the North end of the village because of cost. This would certainly have clamed down the incidents of high traffic volumes and speeding vehicles. What have we got now? A small flashing speedwarning sign that no-one seems to take notice of. If the councils were serious about traffic flows they would do something about speeding motorists that habitually drive in excess of 40mph in the High Street., Some drive on the pavement and many cars have been damaged by reckless drivers. So please, District and Parish Councils, do not claim that traffic visiting Wildtracks causes danger when the blame lies with the weekday rat-run speeders that you do nothing to stop.

I hope that my comments are noted. A hotel on the site would bring a lot of extra employment to the area. It will hardly affect village traffic. And it is a much-needed expansion in accommodation on a major trunk road, in a major tourist area.

Like most young people I look on in disbelief at the way that most politicians behave. So did the original decision not to oppose the application by East Cambs District Council suddenly change when they realised the local elections were upon them?"

Reply from the Chairman of the Parish Council "Dear Jordan,

We are very pleased to hear that Wildtracks has given you the opportunity to learn the sorts of life skills that you have attained. This is what a local business should be doing and should continue to do.

The decision of the Parish Council to oppose the hotel and racetrack development at Wildtracks was made after lengthy, detailed discussion and not by self interested people overlooking the needs of society, young or old. It was felt that a development of this size and one that caters mainly for corporate clients was harmful to the environment and inappropriate for the area.

The Parish and District councils can quite legitimately object to the increase in traffic due to the sheer size of the hotel. 120 rooms means a significant increase in journeys to and from the site for deliveries of food, laundry etc., staff, not to mention the hotel residents themselves. There would be an increase in traffic through the village and the rest of the Parish so our concern has to be mentioned. This would mean a large increase and demand on the local highways. The site also has an important water course and spring on it so there is an environmental impact. These are the sorts of issues councillors have to think about and balance with the prospect of a few more job opportunities.

We would just like to point out that the District and the Parish Councils have always been against the proposal for a hotel and racetrack at the Wildtracks site. The only people that recommended the site for approval were the paid officers of the District Council Planning Department, so there was no change in Councillors' opinions just because of the impending election. Please try not to be too cynical!

In answer to your queries about Chippenham's traffic calming. You are correct that we could not accept the kind offer of a piece land for a roundabout and that it would reduce the speed of traffic coming into the village from Fordham. A great deal of Parish Council time was taken several years ago to explore all the options of traffic calming in the village and whilst a roundabout was the ideal option, the cost of over £100,000, which had to be funded solely by the Parish Council made the roundabout project unworkable. The work than carried out was the first stage of ongoing traffic calming measures. The kerb changes made by the Parish Council have reduced the overall speed of traffic in the village. The Police carried out a survey last August which showed that, despite the increase in traffic since the previous survey in 1998, only 3% of the vehicles were speeding in the High Street. This is 5% fewer than in 1998. Since then we have also had some extra warning signs and road markings put in at the other end of the village by the Bowls Club.

You are also correct in saying that cars drive along the pavement, this had already been noted by us. Two

months ago we ordered the installation of three bollards on the pavement between the village hall and the pub to stop it and we are waiting for them to be put in.

Jordan, please be reassured that the Parish Council is well aware of all sectors of the community and constantly works with all the authorities to help keep Chippenham the great Parish it is."
